Cr Ian Pryor has been promoting the "welfare bureau" idea from council's side.

He says Melbourne has similar welfare centres, but this would be a first for country Victoria. Council has allowed cash to get the bureau started in its 1979-80 estimates, but the project's fruition depends on State Government

backing.

In letters to Social Welfare Minister Mr Jona and local Members of Parliament, council has asked the State to contribute a welfare officer and half the salary of a receptionist, plus half telephone and rent costs.

Council would pay the remaining costs—amounting to a contribution of a few thousand dollars per year.

Cr Pryor: "It's the best welfare package we could get for the ratepayers' money"

Echuca district would then have "one-stop welfare shop—a great centre."

At a city offices on Wednesday, council tried to gain the support of surrounding municipalities for its welfare bureau idea. Representatives of Deakin, Rochester and Cohuna councils attended. Murray and Gordon Shires were invited but did not attend. Those present seemed to support the idea and have now taken the proposal back to their council chambers for consideration. Promoters of the planned centre hope it may be in operation later this year.

Organisers have planned an eight minute rest break between the leaving of the last expert boat and the start of the family class.

While the high speed action is expected from the 20 boats in the expert class, much of the real fun of the day should come in the family class

But while spectators can enjoy a brief sleep in on Sunday Morning, boat crews and skiers will be up with the sun. The first briefing for the day will be at 8.30 a.m. at the Torrumbarry launch site for the expert class, followed by a second briefing at 10.15 a.m. for the family.

Mr Beehag said all boats must be scrutineered by 10 a.m. and all boat crews must attend briefing sessions.

The first 20 boats, the fastest in the trial, leave each three minutes from Torrumbarry, followed by the remainder of the expert class at two-minute intervals.

Echuca City Council has reacted sharply to a letter criticising accommodation it provided recently for a travelling youth group.

Echuca Apex Club wrote to Monday night's meeting of council condemning facilities granted to 20 young cyclists.

The club said it was disgusted at the totally unsatisfactory accommodation provided.

Twenty youngsters pedalling about Victoria under the banner of the Reach out for Kids Foundation stayed in Echuca overnight on January 8.

The group was accommodated in the old luncheon pavilion at Victoria Park.

The Apexians' letter said comments from the young people involved led them to believe that the Victoria Park accommodation was by far the worst they had been given on the round Victoria ride.

According to the club, Echuca earned a poor reputation in the estimation of the young people involved.

It urged that something be done to relieve the situation if and when Echuca is given another opportunity to host participants in the next round-Victoria ride.

Council objected to the criticism by the club and Cr Don Oberin argued that council had done its best for the visitors in the time available.

The Mayor, Cr Brian Wearne, reminded councillors that "another local group" had originally accepted responsibility for organising accommodation here, but had opted out only shortly before January 8.

He said the deputy Town Clerk, Mr Noel Noelker, had worked to ensure that at least some accommodation was available once this other group had backed out.

Supported by Cr Noel Murphy, Cr Oberin successfully moved that the Apex club be told that council did its best under the circumstances and, if it was unsatisfactory, "we are sorry."
