





#### GUIDE TO REQUIREMENTS FOR SCRUTINEERING.

M.S.B. Licence to be produced.

Boat Registration Label attached to boat.

Boat Registration Numbers clearly printed and in correct position.

Has the craft the necessary inbuilt buoyancy?

If the above in the negative is a suitable tube or other buoyancy installed?

Are the following all securely fastened?

1. Battery, 2. Fuel Tanks, 3. Buoyancy, 4. Motor/s bolted, clamped, 5. Fire extinguishers.

Steering: Cable in good condition, Drum secure, Tension of cable satisfactory, General condition satisfactory.

Lock collar above Cav Plate on rubber.

Lock collar on Prop Shaft forward of log.

Are throttle springs loaded too close at the motor/s?

Propellers satisfactorily pinned or lock nutted.

Over transom exhaust system must be muffled and water injected (as per A.W.S.A. regulations)

Suitable secure seating for both driver and observer.

All crew members skis and safety equipment must be produced at scrutineering.

A.W.S.A. competition licence must be produced in all classes at scrutineering.

All boats must carry at least one flare.

Spot checks prior to start on race day.

#### **CONDITIONS OF ENTRY**

- 1. Skis used in all novice classes must meet V.W.S.A. rules.
- 2. Novice classes to quote make and model, cubic capacity of engine, exhaust system used.
- 3. In novice classes all boat motors to be naturally aspirated.
- 4. (a) All drivers must have current V.W.S.A, M.S.B. or appropriate State licence and must forward photostat copy of licence with entry form no start and/or disqualification.
  - (b) All boats must carry current registration and a copy of the certificate must be forwarded with entry form.
- 5. Noise level not to exceed M.S.B. reg. 85 D.B.A.
- 6. All boats to be equipped with M.S.B. regulation safety equipment. Driver and observer to wear life jacket (not ski vest). Skiers to wear ski vests (leg straps and regulation helmets, all boat crews, all classes), No Mae West All skier vests and jackets must have 3 or more straps encircling the body and must be predominantly yellow, red or fluorescent.
- 7. Orange flag to be carried in boat and displayed when recovering fallen skier, being disabled or needing assistance. Flares to be used in an extreme emergency only.
- 8. No alcohol can be consumed before or during the race. No alcohol to be carried in boats.
- 9. All fuel tanks must be firmly secured. No plastic containers, no refuelling whilst boat is in motion.
- 10. All boats competing must supply white painted board 37 cm square attached to boat and must be clearly visible from either side of the boat for 30 metres. Indentifying numbers will be advised by Moama Water Sports Club Ltd. Race number will be advertised in program which will be available Thursday 11th. February, 1988.

#### 11. MOTOR MUST NOT BE RUNNING 30 SECONDS BEFORE ACTUAL START TIME

- 12. It is the crew's responsibility to be at start line 2 minutes before actual start time.
- 13. Odd numbers port side. Even numbers starboard side approaching starters platform.
- 14. Misconduct towards M.W.S.C. Officials and Judges will lead to disqualification of the boat and crew.
- 15. Judges decision is final and no correspondence will be entered into.
- 16. The club reserves the right to refuse entry to any competitor.
- 17. There must be no substitution of crew members after the start of the race.
- 18. Withdrawal of Boats. You must not proceed along the course until after the course is closed.

**Disabled Boats** must display orange flag at all times and remain with boat. You will be collected and towed to the nearest ramp on completion of the race and after the sweep boat clears the river.

19. A novice ski team may not consist of any two skiers who have competed on race skis in the last two point score seasons.

#### \* FOOD AND FUEL WILL BE AVAILABLE AT START AREA \*

All Campers — buses to pay fees at the Victoria Park Office on arrival. Buses to park near Caravan Park flood bank.

All boats to be scrutineered on Friday 12th. February between 4 p.m. — 7 p.m. and Saturday 13th. February 1988 between 10 a.m. — 5 p.m. at Victoria Park Boat Ramp, Echuca.

#### \* OFFICIAL PRACTICE TIMES \*

10.00 a.m. to 5.00 p.m., Saturday, 13th. February

from the 5 mile boat ramp upstream to Victoria Park boat ramp only.

All placegetters may be rescrutineered before presentations.
